CedarWood is honored to be a part of your plan to “bring up of your children in the ways of the Lord.” Therefore, it is with sincerity and truth that we ask each one of you to re-enroll your child for the 2017-2018 school year.

We have always done everything possible to make Christian education affordable for everyone who sincerely desires a Christian education for their children. Therefore tuition and book & registration fees will remain the same for the 2017-18 school year. We will continue to use FACTS for ALL student billing and require each family to have an account. Families not using FACTS for tuition payments will incur a monthly surcharge.

It is imperative that we know your intentions for the coming year to make plans, order books, and know faculty needs. Therefore, we are sending home the enclosed re-enrollment form that has several options that you may indicate your desire and how you wish to make your payment.

As in past years, there is a discount for those who pay their 2017-2018 book and registration fee early, by June 20. All families must make their re-enrollment payment by July 20, so we have an accurate account for ordering supplies and teacher placement. Otherwise, there will be a \$50 late fee charged to those who do not sign up by the deadline of July 20.

Student Re-Enrollment Commitment 2017-2018

Registration & Book Fee (Non-Refundable):

Elementary Students (Grades K-6 th)	\$295.00 – per student
Jr. High/Sr. High Students (Grades 7 th -12 th)	\$435.00 – per student

Registration & Book Fees:

The Registration fee covers the cost of maintaining official records, purchasing and scoring of achievement tests, and maintaining financial records. The Book fee allows the school to purchase books and classroom supplies. It also entitles each student to receive a yearbook. **This non-refundable fee guarantees enrollment and must be paid in full by Thursday, July 20, 2017, to avoid the Late Enrollment Fee of \$50.00 per student.**

This year, CedarWood families will make their Registration & Book fee payment through the FACTS program. No payments can be made at the office.

Pay Book & Registration Payment Fees in full by Tuesday, June 20.

CedarWood will deduct \$100.00 from the first month's tuition total for families who have made their Registration & Book fee payment in full by this date through the FACTS payment system.

Pay Book & Registration Payment Fees in two payments:

First Payment (Half) on Tuesday, June 20

Second Payment (Half) on Thursday, July 20

CedarWood will deduct \$50.00 from the first month's tuition total for families who make their Registration & Book fee payment in two installments, through the FACTS payment system, completing it by Thursday, July 20

Pay Book & Registration Payment Fees in full by Thursday, July 20.

All Book & Registration Payments made after July 20, will incur the Late Enrollment Fee of \$50.00 per student.
